



#### Challenges:

Accommodating fast growth with short lead times, being proactive, responsive and cost effective.

Being one step ahead of our production growth needs by working closely with all departments and looking forward to build capacity for the future.

In addition to providing typical facilities functions, we are responsible for 50+ capital projects annually that range from \$10,000-\$10 million, from simple office renovations to building additions to complete new buildings.

#### Accomplishments

James Street – 108,000-square-foot renovation for production facility, between December 2010 and early January 2011 - 15,000 hours invested

70,000-square-foot renovation to our Zeeland Distribution Center – three month's duration, with no interruptions in service.

Over the last few years, we have implemented various cost savings/cost-avoidance opportunities, including: Utilizing excess heat from the air compressors to preheat RO water. This, in turn, allowed us to turn off the tank heaters in the glass washers on the production lines.

Perform annual compressed air leak audits in all our facilities

Complete review of the HVAC time of day schedules to better coordinate with the facilities occupancy schedule

Modifications to building chilled water system from full flow to variable flow system for energy savings.

As a small team, compared to our overall company size, we are integral to our processes' success and impact many aspects of every Gentex team member's work environment. Many times our team is unseen and unknown. We are proud to support the teams responsible for getting Gentex product out the door, as well as provide a safe, pleasant place to work and bring our customers.

# Wayne's World - Improving Yourself

So...you've been in your position as a professional facility manager for some time now and you are pretty comfortable and confident in your capabilities. Are you becoming complacent? Are you staying current?

I know I made some humorous (I hope) references to using technologies such as Twitter and Facebook but there is a LOT more to our jobs than that, isn't there? How about green cleaning, or the rest of the whole topic of sustainability, or utility monitoring, or financial metrics, or emergency preparedness, or performance assessment, or regulatory compliance, or software upgrades, or whatever? The list can get lengthy.

Opportunities for improving yourself and your career abound. There are numerous online webinars – many of which are free. They last for about an hour and you have lots of topics to choose from. For example Planon is offering a May webinar called "Learning to Speak Finance for Real Estate & Facility Executives," and they just had one on energy benchmarking. The cost is free and the topics are germane for all facility managers.

The government is another source of free information and training. You have been reading and hearing about energy management and "Going Green." Some of us are more tuned in to what that means than other facility managers might be. How do you know where your facilities stand or how they compare to other facilities? The Federal Department of Energy (doe.gov) offers free energy assessment tools that are yours for the taking.

If you travel any distance, there are books on CD that are available at your local library. Listen to them on your way to work or when you travel to a remote site or when you are on a plane.

If you have the financial resources, there are courses offered at area colleges and universities. In many cases your employer will reimburse you for satisfactory completion of class work. Ferris State University offers one of the IFMA-certified FM degree programs. Other institutions offer classes that may be specific for your particular needs. IFMA also offers courses in the nine core competencies at World Workplace and other sites throughout the year.

If you do not have the financial resources to pay for classroom instruction, there are a variety of scholarships available. Stay tuned to the West Michigan Chapter for more news on this possibility in the near future.

**FACT:** Your West Michigan Chapter has 18% CFMs which is 7% higher than the national average. We have 6% FMPs which is about the national average.

#### Fargo-Northern Plains Chapter of IFMA

The Fargo-Northern Plains chapter of IFMA hosted a CFM review course in March to help those interested in getting their CFM. The chapter offered the review course to each local chapter member for free, and gave a discounted rate to non-Fargo Chapter IFMA members. Peggy McCarthy, CFM, CFMJ, IFMA Fellow, from the Minneapolis-St. Paul IFMA chapter led the course.

In addition to the review course, the Fargo-Northern Plains chapter is focusing their monthly chapter meeting topics on competency areas members feel they are least knowledgeable in. They invited professionals from the community working in those competencies to give an informational presentation at the monthly chapter meeting. In April, a local real-estate broker gave a presentation on commercial real-estate and leases, and in May a finance director from a local hospital is scheduled to give a presentation on financial statements and reports.

Fargo-Northern Plains chapter of IFMA has 23 members and covers eastern Montana, eastern South Dakota, western Minnesota, and all of North Dakota.



# Focus

### Environmental Issues in FM - Here, There and Everywhere

Environmental issues subject to Michigan and federal environmental law can be present in any facility, whether you are planning new construction, remodeling existing structures, or managing historical buildings. For professional facility managers, energy efficiency and waste management have become routine, and resources are available for continuous improvement. Other environmental issues arise infrequently, usually in the middle of major changes, and of course, you need to keep an eye on your neighbors.

Some issues you might face are:

**Environmental Due Diligence** – this is pertinent when you purchase new property or refinance existing properties, and is largely a process of looking for trouble under your feet – soil or groundwater contamination. The process includes a Phase I Environmental Site Assessment – a visual and historical survey, which could then extend to a Phase II investigation – soil and/or groundwater sampling and laboratory analysis. The good news in this process is that Michigan environmental law provides an exemption from liability for contamination that was present before you purchased a property.

**Due Care** – if your property has soil or groundwater contamination, either from past use of the property or from migration from a neighboring property, you may have responsibilities to avoid making the contamination worse and to protect against exposures to contamination. This is often as simple as maintaining a parking lot over contaminated soils, connecting to city water, or fencing off the back lot.

Asbestos and Lead-Based Paint – asbestos-containing pipe insulation, floor tiles, fire doors, etc. could be present in any building built before the mid-1980s. Similarly, lead-based paint could be present in any residential building built before 1978. It is still used on structural steel. Either of these conditions can be an expensive factor in demolition and renovations, with intense oversight by state regulators.

**Storage Tanks** – underground storage tanks (USTs) and above-ground storage tanks (ASTs) are used for backup generators, heating oil, and specialty chemicals. Depending on the size, use, and contents of the tank, there are different state regulations, and spills or leaks are always a problem. Users of larger tanks or multiple tanks are required to have detailed spill plans.

**Vapor Intrusion** – this is an issue where previous occupants, neighbors, or neighbors from long ago can produce present-day problems. Volatile organic compounds from gasoline, paints, dry cleaners, etc. can migrate through soil or groundwater and seep into buildings. This issue has recently come under scrutiny by Michigan environmental regulators.

To find out whether any of these issues are present in your facility, and what to do about them, environmental consultants are available with specialized knowledge. Some issues may require consultation with legal counsel. Don Penniman and Shawn Shadley of ASTI Environmental are available any time for a conversation at 616-957-5601.
